NOTICE IS HEREBY GIVEN that a Municipal Election will be held in the City of Orinda on Tuesday, November 3, 2020, which will include the following measure:

ORINDA ESSENTIAL SERVICES MEASURE To help maintain and enhance essential City services, including wildfire risk reduction throughout Orinda, preparation for emergencies and disasters, repair of public storm drains, continued public street maintenance, and other city services, shall the City of Orinda increase its existing one-half cent sales tax to one cent, which would generate approximately \$2.4 million annually for a period of twenty years, with financial audits, public review of all expenditures, and a citizens' oversight committee? 
NOTICE IS FURTHER GIVEN that pursuant to Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, the legislative body of the City, or any member or members thereof authorized by that body, or any individual voter who is eligible to vote on the measure, or any bona fide association of citizens, or any combination of voters and associations, may file a written argument, not to exceed 300 words in length, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the City measure. A Statement that the argument is true and correct, signed by the authors, must accompany all arguments; a sample of this form is available by contacting the City Clerk at 925-253-4221 or by email at ssmith@cityoforinda.org.

NOTICE IS FURTHER GIVEN that Wednesday, August 19, 2020 at 5:00 p.m. is the deadline for submission of arguments for or against the City measure to the City Clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, at the City Clerk's office, City Hall, 22 Orinda Way, Orinda, California. (Please contact the City Clerk at 925-253-4221 or ssmith@cityoforinda.org to make an appointment as City Hall may not have regular business hours due to the COVID 19 Pandemic.) Arguments may be changed or withdrawn until 5pm on the date they are due.

NOTICE IS FURTHER GIVEN that the City Council has determined that rebuttal arguments, not to exceed 250 words in length, as submitted by the authors of the opposing direct arguments, may be filed with the City Clerk at the City Clerk's office, City Hall, 22 Orinda Way, Orinda, California. (Please contact the City Clerk at 925-253-4221 or ssmith@cityoforinda.org to make an appointment as City Hall may not have regular business hours due to COVID 19 Pandemic.) Any rebuttal argument must be accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, and submitted no later than 5:00 p.m. on Monday, August 24, 2020. (Please contact the City Clerk at 925-253-4221 or ssmith@cityoforinda.org to make an appointment as City Hall may not have regular business hours due to COVID 19 Pandemic.) Rebuttal arguments may be changed or withdrawn until 5pm on the date they are due.

NOTICE IS FURTHER GIVEN that any impartial analysis, or direct argument filed under the authority of the Elections Code will be available for public examination for ten (10) calendar days from the deadline for the filing of the arguments and analysis by contacting the City Clerk at 925-253-4221 or ssmith@cityoforinda.org. Any rebuttal argument filed under the authority of the Elections Code will be available for public examination for ten (10) calendar days from the deadline for filing rebuttal arguments by contacting the City Clerk at 925-253-4221 or ssmith@cityoforinda.org.
